118TH ANNUAL CONFERENCE MAKES HISTORY

The Kansas Society 118th Annual Conference conducted on March 20, 2010 was historic for many reasons. Held at Fort Leavenworth, the event retained the core of an annual meeting while presenting new facets to the attendees.

Attendees compared the late winter setting at the Fort to what it must have been like at Valley Forge in 1777. But the blowing snow did not deter all compatriots from braving the elements as they traveled by auto from distant locations such as Fort Scott, Wichita, and Oklahoma City. The weather conditions provided a unique backdrop for the Conference.

What made this Annual Conference historic was the presence of the NSSAR President General and the revised one-day format for an off-year meeting. Maybe the snow helped, too. Attendees and guests met with Edward F. Butler, the President General, who had flown in from Chicago on a return trip to his home in San Antonio, TX. South Central District Vice President General Dr. Frank Appl arrived on Friday, as well, for pre-meeting activities.

Informal activities commenced on Friday, March 19,

2010. The President General, accompanied by Barnett Ellis and Peter Grassl, received a private tour of the Command & General Staff College's Lewis & Clark Center. The tour was led by LTC Ed Kennedy, US Army (ret), who is an instructor at this incredible facility in which all Army majors receive critical training. The Center is a state of the art facility filled with artistic pieces (print, stain glass, displays) which depict the Army from the Revolutionary War to the present.

A causal dinner on Friday evening took place at June's Cottage near downtown Leavenworth. The Henry Leavenworth Chapter, which hosted the conference, calls this quaint, antiques-theme restaurant home to their meetings on the fourth Thursday evening of each month. An unexpected over-flowing group of compatriots and spouses made for a festive dinner spanning several rooms.

Rain changed to heavy snow overnight. Some compatriots had spent the evening at the local host motel. Others were fearless on Saturday morning and made the trek up K-7. It would prove worth the trip by the end of the day.

The conference opened with a tour of the Army Frontier Museum. Those who have visited other Army museums rate this to be one of the best in the country based upon content and design. It describes how Kansas and the west was discovered, mapped, and opened up to settlement, followed by a history of the Fort.

Memorial Chapel and led by KSSSAR Chaplain Brian Vazquez. Unfortunately, a record number of compatriots were remembered. The Chapel was constructed in 1878, several years after the Battle at the Little Big Horn, and there are numerous plaques recognizing those who fell during that battle. Following the service, compatriot Dick Wright provided an oral history of the Chapel, constructed

to "right the wrong of the heathens of that period."

A very tasty lunch was held at the Museum and was catered by June's Cottage. President General Butler offered remarks about the very positive progress being made with the Library component of the new Center for Advancing America's Heritage (CAAH) center in Louisville. A new librarian has been hired who had previously interned with the SAR. A move into the new library will take place this year. The CAAH is being funded primarily by compatriot donations and grants from private organizations. The President General departed with donations expressing the support of the Kansas Society.

Frank Appl, South Central District Vice President General, spoke to the importance of the George Washington fund, which he chairs. He pointed out that dues go for the day-to-day operations of the Society. Any extras are paid from George Washington fund investment income. (The two newest chapters in the Kansas Society have benefited from GW fund donations.)

The winners of the Youth Programs were recognized. Kirsten Marie Krull (pictured left) won the Knight Essay Contest representing Delaware Crossing Chapter. Brian Denning (pictured below) was recognized the winner of the King Eagle Scout Scholarship Award; he is a senior at Gardner-Edgerton High School. The poster created by Sydnie Cross was selected winner of the Americanism Poster Contest; she was sponsored by Delaware Crossing Chapter.

A very brief business meeting was held to elect a National Trustee, Alternate, Delegate at-Large, and Heritage Fund Trustee. Those individuals are: Peter Grassl, Bob Capps, Edgar Grover, and David Comer, respectively.

Concluding the luncheon was the presentation of gifts to our distinguished national officers. The President General received a framed print of the "Four Patriots" by Cmpt. Charles Goslin. VPG Appl was presented a "Patriot's Plaque" used for the 2013 fund raising.

Compatriots and guests boarded a chartered bus for a guided tour. The Fort dates from 1827 and is the oldest such establishment west of the Mississippi River. Dick Wright, compatriot and "certified" tour guide of the Fort, told of the important history and importance of the buildings and events over the past 150+ years.

One of the key points in the promotion of the Annual Conference was the laying of the wreath at the grave of General Henry Leavenworth. The weather conditions threatened to hamper this concluding activity. "We" really didn't know if the placement would take place until the tour arrived at the grave site.


Standing in formation on a hill above the grave was the Leavenworth High School Junior Army ROTC unit wearing Revolutionary War era uniforms. What a sight to behold! Those young people had made it through the weather to be part of the ceremony!

The opening of the wreath-laying service was led by Peter Grassl and Brian Vazquez standing at the front of the bus. Most of the tour group was motivated by the JROTC standing in blowing snow to disembark the bus to take part in a photo shoot and observe the placement of the wreath. If our Revolutionary War ancestors could brave the snow, so can we!

The President General, KSSSAR President, and Henry Leavenworth Chapter President moved the wreath down a shoveled path (thanks to HL President Lyles) and past the Color Guard. The JROTC unit joined the presentation for an incredible conclusion of men saluting the history of the General, a "real son" of the American Revolution, amidst snow blowing across the cemetery.



What a conclusion to a history making 118th Annual Conference! This was a new approach to the off-year meeting by shortening the activities and including an historical tour. Thanks go out to the Henry Leavenworth Chapter President Brooks Lyles and his wife, Diane Ungvarsky, to Dick Wright, and to the other HL compatriots for hosting this exciting meeting.

Cmpts. Barney Ellis and Peter Grassl received the Arthur M. King Boy Scout Volunteer Award last year. Cmpt. Mark Naughton is being recommended for 2010 because of all the work he has given to scouting.

As of February, 2010, the spreadsheet for tracking prospective members contained 452 names and addresses. Of the 452 prospects, 20 have applied for membership since August.

GEORGE WASHINGTON ENDOWMENT FUND & FRIENDS OF THE LIBRARY — Barnett Ellis

The National GWEF Distribution committee continues to help support various causes that states request. It also pays for the breakfast for Orations contestants.

The December 31 report for the Kansas membership in Friends of the Library shows Kansas with 12 members or 1.8%. The states with the largest percentage of members are Tennessee with 3.6% and Missouri with 3.6%. The national average is 1.01%. Thanks to eight Kansas members for supporting the SAR Library.

Building construction on the library in Louisville is on or ahead of schedule, and at or under cost.

published since converting to email subscription. *The Liberty Bell* was emailed to 518 subscribers and sent to the webmaster for posting to the KSSSAR website on February 5. The printed version was mailed to 32 subscribers at a cost of \$85, which includes first class postage, copying costs, and supplies (labels and tabs).

There are several immediate effects of switching the means of distributing the newsletter, going from print/mail to email. Bulk mailing cannot be used since the number of mailed pieces have fallen below 200, so the postage rate goes from \$.16 to \$.44 for each newsletter. The newsletters will now be copied rather than printed since the print setup cost makes the latter infeasible for a small number of newsletters; this slightly lessens production quality. The email process is also affected; it will need to be spread across two days because my email account provider limits the number of outgoing emails to 500 per day.

The BOG approved a motion to terminate the Bulk Mailing Account (permit #341) since it is no longer needed.

TREASURER - Gerald Cox

Consistent with trends throughout NSSAR, 2010 KSSSAR dues payments have declined somewhat. In 2009 the BOG approved reducing award values for youth competitions and changing the means of distributing the *Liberty Bell* to email. These actions should significantly reduce our operating expenses going forward. However, careful budgeting for 2010 is required.
