## SCD ANNUAL MEETING LEADS THE WAY

The annual meeting of the South Central District was held August 21 - 22 in Irving, Texas. There were 61 SAR members attending along with 21 ladies.

Eight Kansas Society compatriots attended: Peter Grassl, Martin Klotzbach, Barnett Ellis, Bob Capps, Tim Peterman, Edgar Grover, David Comer, and Jake Cox.

A candidate forum was held late Friday afternoon. This was followed by a reception and a banquet. Franklin J. Appl (OK), VPG of the South Central District, conducted the meetings. President General Edward F. Butler (TX) offered remarks following the banquet. At the conclusion, the men adjourned to a roundtable session. The topics discussed included the George Washington fund and the DAR Finders Form.

The South Central District meeting was called to order Saturday morning by VPG Frank Appl. Presentations were made by Dr. Sam Powell, Chairman, Center for Advancing America's Heritage, and by Colleen Wilson, Acting Director, Center for Advancing America's Heritage.

A motion was passed to close the SCD checking account due to inactivity and have the host society handle the costs for annual awards presented at the SCD meeting. The current funds will be evenly distributed to the George Washington Endowment Fund and the Center for Advancing America's Heritage.

### \* PRESIDENT'S CORNER \*

Compatriots All ---

I just returned from attending the Fall Leadership Conference. The high point was the symbolic Cornerstone Ceremony for our new headquarters. The building has been gutted, the walls braced, and the floors reinforced for handling the weight of the library. The gavel used during this event was the same gavel used by President George Washington in the Cornerstone Ceremony for the U.S. Capital in 1793. The head was made from the same marble used in the Capital, and the handle from Rosewood in the area. It was reported that this facility was being considered by the Smithsonian Institute as an associate. This would allow the display of some of their artifacts by our new building.

Kyle Kesler made his initial trip to a national event, joining Ed Grover, Barney Ellis, Peter Grassl, Bob Grover, Bob Capps and myself. For those who have never attended a national gathering, give some serious thought about joining us for the Leadership Conference next March. Hopefully, you will enjoy the experience as much as Theresa and I do.

Another high point was a joint meeting of the Missouri delegation (including State President Dan McMurray), the Kansas delegation (including myself), and the NSSAR Congress Planning Committee Chairman, Larry Guzy. The 2013 Congress co-host planning chairmen, Peter Grassl of Kansas and Dick Bryant of Missouri, brought everyone up to date. It was agreed by all to proceed with the production of a Congressional medal to raise funds. The Congress Planning Chairman was particular helpful with his suggestions and comments. Looking ahead, I pray for a huge turnout of Kansas Society members to be in attendance at the National Congress in Kansas City in 2013. The Congress will never be any closer. It goes without saying that we will need many to volunteer when called upon to help and fill the many jobs that will arise.

Since last spring the turn-around time for new applications has improved, going from nine weeks to eight weeks. The trustees have approved a fast-track process for new applicants when based on a father or grandfather.

It seems like every day most of us receive mail requesting funds for some needy cause. It is no different for SAR members. As a member of the George Washington Endowment Fundraising Committee, I see the results of our efforts periodically. The fund is now above \$1 million again as the market improves. We were down to a balance of \$800,000, a new low. Kansas has had only one new member, Ray Peterman, pinned for his completion of his \$1000 pledge this past fiscal year. We only have two members in the pledge pipeline. From what I have seen, Kansas would be recognized if we had only two and a half percent of our membership give an average of only \$250.00. Surely, we can do that. Any question about how to do that, just call or send me an e-mail. Earnings from this trust go to deserving, unfunded or under-funded national committees. Oh, and don't forget to buy some quilt raffle tickets to help fund the Kansas expenses for the 2013 Congress in Kansas City. Some states have raised funds by putting a surcharge of \$3 to \$5 on their annual dues. We would rather make it voluntary.

It goes without saying that the Center for the Advancing American Heritage (CAAH) is another high priority. We need to continue to pledge in order to complete the remodeling of the new building. And the Friends of the

#### FAMILY TREASURE DONATED TO SAR

Cmpt. Richard "Rick" Fulton, of the Fort Scott Chapter, recently donated a family heirloom to the SAR for display at the national headquarters in Louisville. The artifact is a well-preserved leather wallet that originally belonged to Enoch Coffin, who is the great-great-greatgrandfather of Fulton's grandmother, Grace Moore Pence.

Enoch Coffin was born on June 1, 1735, at Epping, Mass., and died in 1814. He was a member of the Provincial Congress of the Thirteen Colonies, a body formed out of the need for communications between towns and for decisions to be made in regard to the colonies' future after the Massachusetts Government Act of 1774 annulled the royal charter of 1691.

"My understanding is that Enoch was in New Hampshire and was a member of the New Hampshire version of the Provincial Congress, which would also have had a connection to Massachusetts," Fulton said. "Enoch might have taken this wallet, which would have been called a pocketbook back then, when he attended the Provincial Congress."

He first saw the wallet in 1948 during a visit to his grandmother, who was an elementary school teacher in Illinois. "She kept it in a paper envelope," Fulton said. After his grandmother died in 1965, the wallet went to his mother, Gertrude Pence Fulton Fleming. Fulton received it after her death in 1997."



For years the family had kicked around the idea of what to do with the wallet," Fulton said. "We felt that it would be best to get it into a museum or some sort of setting where people could see it. This wallet dates back to the time when we were trying to pull together a government in America. It's a political artifact."

The family considered contacting the Smithsonian in Washington, but the decision was made to give it to the SAR, to be placed on exhibit at the national headquarters.

The wallet was presented to the SAR at the Trustee Meeting in Louisville this past September. Although Fulton was unable to make the trip, he gave it to Cmpt. Barnett Ellis to do so in his stead.

"The SAR has done yeoman work to verify all this information," Fulton said. "The family has come up to the bat to give the wallet to SAR, and we're also taking up a collection to pay for a display case for it."

Fulton, along with his sons, Shawn Spickert-Fulton and Travis Spickert-Fulton, are new members of the Fort Scott Chapter.

#### CAAH GROUNDBREAKING

In late August, NSSAR started Phase I of the construction project, which will house the Genealogical Library in its new location at 809 West Main Street in Louisville. The ceremonial beginning featured PG Ed Butler and Louisville Mayor Jerry Abramson, who proclaimed August 25, 2009, as the Sons of the American Revolution Genealogical Library Day.

The Genealogical Library is the cornerstone of the preservation and conservation of important documents pertaining to the families of those who participated in the American Revolution. The library has extensive census records, family histories, vital statistics, photographs, and other historic documents. It is scheduled for completion in early 2010 and projected to cost \$2.5 million.

Plans call for moving the national headquarters to the new building and developing the Center for Advancing America's Heritage, which will be used to provide educational outreach programming and to include traveling and permanent exhibitions, tours, and historical symposiums completed in phases and is projected to cost as much as \$10 million.

The current headquarters features a number of historical artifacts and exhibits on display, including George Washington's seal ring and a life-sized replica of the Liberty Bell. It also hosts hundreds of school field trips per year, and schedules public tours and events on a regular basis.

#### CONGRESS 2013 - Peter Grassl

A separate checking account is being created for the 2013 fund raising effort, moving the money from KSSSAR general accounting. A search is on to find someone to serve as the 2013 fund raising treasurer.

A "thank you" note is to be included with each Kansas plague. The note will include an image of the skyline of Kansas City if such a one can be found.

The cost of the quilt (to be auctioned) is \$374.12. A check for \$125.88 (which is the balance due of \$500 loan) is needed from Thomas Jefferson Chapter.

A rough accounting summary of current fundraising is: \$2,700 from Plagues and \$355 from Quilt Raffle, for a total of \$3,055, leaving \$6,945 to go.

#### **GENEALOGIST** – Timothy E. Peterman

As of April 2009, the spreadsheet for tracking prospective members contains 430 names and addresses. The spreadsheet includes columns to track assigned chapter, assigned sponsor and application progress. New prospects are added to the list as they are discovered or reported. Assigned sponsors are asked quarterly for a progress report, and the status is recorded accordingly. Of the 430 prospects, 12 applied for membership between May and August.

Many of these prospective members lack a working sponsor. Volunteers are needed to sponsor viable prospects. Current members with genealogical and communications talent are encouraged to apply.

The next issue of the "From Kansas to Concord" newsletter is scheduled to be distributed to prospects in August or September.

Outreach booths were staffed at the following events: Turkey Creek Festival in Merriam, Good Ole Days in Fort Scott, and Tonganoxie Days.

No genealogy workshops are scheduled at present.

# Reports

The June 30 report for the Kansas membership in Friends of the Library shows Kansas with three members, or 0.45% of all members. Yes, that is less than 1%. The states with the largest percentage of members are Tennessee with 5.7% and Missouri with 3.7%. The national average is 1.1%. Kansas needs five new members to equal the national average. I will have forms with me at the BOG; it is \$25 per year.

#### KANSAS HERITAGE TRUST - John Forbes

Since Life Memberships have been suspended at the National Level, a by-law change may be in order since members of this committee must be life members.

#### MEDALS AND AWARDS - Peter Grassl, Barnett Ellis

KSSSAR won first place in the Paul M. Niebell, Sr. award for newsletters. The \$300 award was presented by PG Appleby to KSSSAR President Klotzbach.

The Eagle Scout medal (chapter) and trophy (state) are no longer free due to financial conditions within the Eagle Scout portfolio.

Following the Awards presentation at Congress, a meeting was held to identify which awards the Kansas Society could pursue and attain with reasonable effort. These include: C.A.R. Activity, Newsletter, Boone McCarty (for compatriots furthering the education of teaching about the Revolution), Eleanor Niebell (for C.A.R. newsletter), Westmoreland (award for compatriots helping veterans), USS Stark Memorial (for state and chapter societies' service to veterans), Friends of Library (by increasing the number of members supporting the library), Robert Vance (for best web page), Adm. Wm Furlong (for flag certificate presentations), Americanism and Officer streamer.

The records that track the medals and awards presented are up-to-date. One file is by medal and shows all known to have received it; the other file is by member and contains only current, active members. Chapters can request a copy of these records by notifying Barney Ellis.

Chapters need to inform Barney Ellis of all medals and certificates presented. Before presenting medals and awards, Chapters should check with Barney to determine whether the compatriot has previously earned or been awarded the medal. Updates have been received from only three chapters since the last BOG meeting.

#### **MEMBERSHIP** – Timothy Peterman

The Kansas Society has 662 members in our march toward 700. We now have functioning e-mail addresses for 361 of our 662 members.

and Joseph W. Ellenberg of Georgia, 3rd place.

Next year's national contest will be June 27, 2010, with check-in on June 26. The state contest will be held May 1, 2010. Chapter contests must be held before the cutoff time of April 15, 2010.

#### THE LIBERTY BELL - Mike Frisbie

The *Liberty Bell* won first place in the Paul M. Niebell, Sr. Award at the 119th National Congress. This earned a \$300 prize. The Paul M. Niebell, Sr. Award is presented to State Societies with over 500 members and judged having the best periodical or newsletter with fewer than ten pages.

The May issue of the newsletter was printed by Command Print of Leavenworth at a cost of \$505.79 for 635 copies. The eight-page newsletters were printed on 70 lb. glossy paper, bi-folded, and tabbed for mailing with CASS -certified addressing. There were seven address changes and eight address corrections reported by the printer.

620 newsletters were mailed July 28 from the Shawnee Mission Post Office; the mailing costs were \$100.83, leaving an assumed Post Office balance of \$444.77.

The electronic version of the newsletter was distributed to 459 email subscribers on July 26. There are currently 161 email-only subscribers, an increase of 53 since the last distribution. The electronic version of the newsletter was posted to the KSSSAR web site. About 20 email addresses were found to be invalid. Address corrections/changes and email errors were reported to the KSSSAR secretary.

The distribution of the *Liberty Bell* will be by email only starting in 2010. For those wanting to continue receiving a mailed, printed copy, an additional \$10 fee will need to accompany their annual dues payment.

At the June chapter meeting, Cmpt. Philip W. Blake presented his much requested presentation on "Veterans Memorials in Wichita, KS."


